INTEGRATING DIGITAL TECHNOLOGY IN *EKOMBI* DANCE MUSIC EDUCATION: A PATHWAY TO ARCHIVING VISION 2030 IN CROSS RIVER STATE, NIGERIA

Abstract

Ekombi dance music is a cultural expression in Cross River State, Nigeria. Diminishing interest among younger generations and insufficient modern educational resources are some of its challenges. This study investigated how integrating digital technologies into ekombi dance music education could contribute to achieving Vision 2030. It evaluates the effectiveness of digital tools in enhancing the teaching and appreciation of ekombi dance music, thus aiding in cultural preservation and educational advancement. Survey, analytical, archival, photographic and video tutorials, interactive apps, and virtual reality experiences were employed. The study is grounded in theories of Technology Acceptance Model (TAM) by Fred Davis in 1989 and Cultural-Historical Activity (CHAT)by Russian psychologist Lev Vygotsky in 1920s and Alexei Leontiev in 1930s respectively. Findings indicate that the use of digital tools was found to create a deeper connection with cultural heritage while making the dance more accessible and appealing to younger audiences. In conclusion, the integration of digital technologies in ekombi dance music education is crucial for cultural preservation and the attainment of Vision 2030. The study recommends that stakeholders should focus on developing and implementing digital resources to ensure the sustainability and growth of ekombi dance music in Cross River State and across the globe.

The *ekombi* dance music, a vibrant and integral component of the cultural heritage of the Efik people in Cross River State, Nigeria, is a traditional dance that embodies the community's history, values, and artistic expression. However, like many traditional art forms, the *ekombi* dance music faces the threat of erosion due to the increasing influence of globalization, changing societal values, and the waning interest among younger generations (Nzewi, 2013). This issue is particularly concerning as it threatens the transmission of cultural knowledge and the continuity of this unique art form.

In response to these challenges, there is a growing recognition of the potential of digital technologies to rejuvenate and sustain traditional cultural practices. Digital technologies offer innovative ways to document, teach, and engage with traditional art forms, making them more accessible and appealing to contemporary audiences (Jones, 2016). Ekombi Dance

Ekombi dance is a traditional dance of the Efik people in Cross River State, Nigeria. It is characterized by graceful movements and elaborate costumes, embodying the cultural heritage and identity of the Efik community. Despite its cultural significance, it faces the risk of decline due to modernization and reduced youth interest (Nzewi, 2013). Ekpa (2012) affirms that ekombi music is gracefully performed by the Efik maidens (young girls/ladies), gesticulating the beautiful signs of womanhood as well as the rich cultural heritage of the Efiks. Ezebube and Anthony (2022) further explain that the music is a display of rhythmic patterns, sonorous melodies, beautiful dance steps and the adorning apparels of womanhood. The musical performance is often demonstrated with flexible hands, swinging back and front like the water waves; supple twisting of the body from chest to the legs like that of the fish or mermaid movement. On the whole, the instrumental accompaniments and vocal text of ekombi music often thrill both the audience and dancers to more graceful body gesticulation at spontaneous pulses and balancing of the pulse marker, ostinato and the rhythmic extemporization of the drums. Ekombi dance formation sways from linear formation to triangular formation and sometimes from semi-circular formation to zigzag formation, depending on the numbers of the performers.

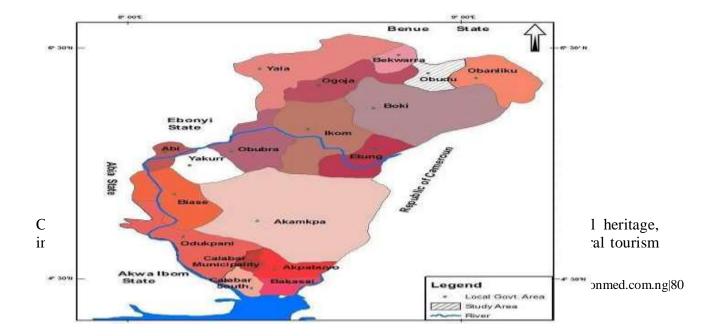
Figure 3: Ekombi Dancers

Technology Acceptance Model (TAM), was introduced in 1989 by Fred Davis. He posits that two primary factors determine the acceptance and use of technology: perceived usefulness and perceived ease of use (Davis, 1989). Perceived usefulness refers to the degree to which a person believes that using a particular technology will enhance their performance, while perceived ease of use is the extent to which a person believes that using the technology will be free of effort. In the context of *ekombi* dance music education, TAM can help educators and policy makers understand the factors that influence teachers' and students' willingness to adopt digital tools in formal education. For instance, if teachers find digital platforms such as Tiktok and youtube among others useful for enhancing students' engagement and comprehension of *ekombi* dance music, and if these tools are easy to use, they are more likely to integrate them into their formal teaching practices. Therefore, ensuring that digital technologies are user-friendly and demonstrate clear benefits in terms of educational outcomes is crucial for their successful adoption in *ekombi* dance music education.

Cultural-Historical Activity Theory (CHAT)

Cultural-Historical Activity Theory (CHAT), was developed by Lev Vygotsky in the 1920s and in 1930s Alexei Leontiev expanded it as well as scholars like Yrjö Engeström in 20th century. CHAT provides a comprehensive framework for analyzing human activities as socially and culturally situated phenomena (Engeström, 2018). CHAT emphasizes the role of cultural artifacts, tools, and social interactions in mediating human activities and learning processes. Applying CHAT to *ekombi* dance music education highlights how digital technologies can serve as mediating tools that transform the traditional teaching and learning of this dance form. By incorporating digital tools such as virtual reality, online tutorials, and interactive applications, educators can create enriched learning environments that reflect the cultural and historical context of *ekombi* dance music. These tools can mediate the learning experience, making the dance more accessible and engaging for students while preserving its cultural essence.

Furthermore, CHAT underscores the importance of community and social interactions in the learning process. Integrating digital technologies in *ekombi* dance music education should not be an isolated effort but rather involve collaboration among educators, students, cultural practitioners, and the community. This collaborative approach ensures that digital integration respects and enhances the cultural and historical significance of *ekombi* dance music, aligning with the goals of Vision 2030.

Cultural Sensitivity: There is a risk that the essence and authenticity of *ekombi* dance music could be diluted or misrepresented through digital platforms if not handled with cultural sensitivity.

Funding and Resource Allocation: Securing adequate funding and resources for integrating digital technologies into *ekombi* dance music education is difficult, especially in a context with competing priorities and limited budgets.

Resistance to Change: There are resistance to adopting new technologies among educators, students, and the community due to traditional beliefs or skepticism about the benefits of digital tools.

Given the foregoing challenges on the integration of digital technologies into *ekombi* dance music education in Cross River State, it is essential to address these challenges before achieving Vision 2030 goals. - ❖ United States: In the United States, particularly among Native American communities, digital technologies have been crucial in preserving and promoting traditional dance music. These efforts have not only preserved cultural heritage but also empowered communities to reclaim and share their traditions in contemporary settings (Smithsonian Institution, n.d.).

In Cross River State, Nigeria, the ekombi dance music practice represents a unique cultural heritage. However, the integration of digital technologies in its preservation and education has been limited. Unlike South Korea and the United States, where government support and institutional initiatives drive digital integration, ekombi dance music primarily relies on oral tradition and occasional live performances for preservation. Challenges such as limited access to digital infrastructure, funding, and educational resources hinder comprehensive digital integration in ekombi dance music education. Efforts to bridge this gap could involve partnerships with educational institutions, cultural organizations, and government support to develop digital archives, online tutorials, and interactive platforms for learning and showcasing ekombi dance music. While South Korea and the United States have successfully integrated digital technologies into traditional dance music education, Nigeria, specifically Cross River State with its ekombi dance music, faces challenges in adopting similar approaches. Addressing these challenges through strategic partnerships and government support can potentially enhance the preservation and educational value of ekombi dance music in alignment with global trends.

Findings

The integration of digital technologies into *ekombi* dance music education in Cross River State, Nigeria has not gained wider implementation, if imbibed, it will yield significant potentials as pathway to achieving Vision 2030.

Digital tools such as virtual reality (VR) and mobile applications has not been instrumental in enhancing student engagement and learning outcomes. If students participate in virtual *ekombi* dance music sessions, there will be reported higher levels of motivation and understanding of dance techniques compared to traditional methods.

There is a fragmented use of online platforms and mobile apps to access to *ekombi* dance among urban audience. When students from remote areas and diverse backgrounds are introduced and couldaccess such instructional materials, tutorials, and historical context that were previously inaccessible, the practice will be sustained.

Digital archives and documentation tools have played a crucial role in preserving and promoting cultural heritage of the Western cultures. Hence, video recordings of performances, historical narratives, and music scores of the *ekombi* dance music could be digitized and made available for future generations, ensuring the continuity and authenticity of the dance form.

There are interactive websites and social media platforms that could be dedicated to *ekombi* dance music to fostered community engagement and collaboration. These platforms serve as hubs for sharing knowledge, organizing events, and connecting with a global audience interested in Nigerian cultural heritage.

Despite the benefits, challenges such as infrastructure limitations and digital literacy gaps among educators and students persist. Addressing these challenges through targeted training programs and infrastructure investments remains crucial to fully harnessing the potential of digital technologies in *ekombi* dance music education.

Conclusion

Integrating digital technologies into *ekombi* dance music education presents a transformative pathway towards achieving Vision 2030 in Cross River State, Nigeria. This initiative has shown immense potential in enhancing educational quality, preserving cultural heritage, promoting economic growth, and fostering social inclusion.
